## Contamination, Land Usage, and Proposed Remediation Section

Provide a brief description of the site contamination, to the extent known, in plain language (e.g., fuel oil spill, historical chemical industrial area, etc.), the current and intended future use of the property in the box below.

In July 2016, refinery personnel discovered product-soaked soil at the ground surface just outside of the emergency containment berm for Tank PB 253. As part of immediate response actions, the area around the product-soaked soil was excavated and removed. In addition, an underground product line which ran north-south along the access road adjacent to this area was suspected by refinery personnel to have leaked as well. This north-south pipe was unearthed and repaired.

Since the release in 2016 and the immediate response actions described above, Philadelphia Energy Solutions Refining and Marketing LLC (PESRM) entered bankruptcy, and PESRM was acquired out of bankruptcy by Hilco Redevelopment Partners in 2020. A Notice of Intent to Remediate was not submitted at the time the release was first discovered in 2016.

The future use of the property is expected to be non-residential.

Provide a general description of proposed remediation measures.

A limited soil excavation was conducted in July/August 2016 following the identification of product-soaked soil east of, and adjacent to, the PB 253 containment berm. The area around the line was excavated and soil was removed. In addition, an underground product line which ran north-south along the access road adjacent to the area was unearthed and repaired.

In December 2021, PERSM completed a remedial investigation to define the nature and extent of constituent concentrations in soil the area of the release. Results of the remedial investigation demonstrate that the extent of release-related contamination (predominantly benzene) associated with the 2016 release is limited to soil and proximal to where the product-soaked soil and north-south underground pipe line were identified. The remedial investigation also demonstrated that groundwater contamination (including light-non-aqueous phase liquid [LNAPL]) identified in this area is associated with prior releases which occurred before September 2012. A prior property owner is responsible for cleanup of releases that occurred before September 2012.

PERSM plans to remediate soil in the area to attain a combination of standards (i.e., Statewide Health [SHS] and Site-Specific Standard [SSS]). Constituents in soil which do not meet SHS will attain the SSS via pathway elimination.


