During demolition and redevelopment activities at the former Philadelphia Refinery, light nonaqueous phase liquid (LNAPL) having a potential release date after September 8, 2012 has been identified near Former Point Breeze Tank Farm. LNAPL that was released prior to September 8, 2012 is also present in this area of the former refinery and is being addressed by Evergreen as Pre-Existing Contamination.

The contamination consists of oil of varying compositions. The specific mechanism of release is not known but, based on aboveground storage tank (AST) closure sampling, does not appear to be associated with discrete releases from ASTs, which have now been demolished and removed. The post- September 8, 2012 LNAPL (oil) is often located in the same general areas as LNAPL that is Pre-Existing Contamination, e.g., was release prior to September 8, 2012. The facility is undergoing redevelopment activities, and the future use will be non-residential.


